

- The Centre for Asylum Seekers: "In Montenegro were adopted a variety of strategies and action plans at the state level dealing with groups that are currently or potentially socially disadvantaged, or deal with specific topics related to social inclusion. As the current social protection system is primarily focused on cash benefits, it follows that In Montenegro, community services are insufficiently developed".

## Flashpoints

- Process identification of minors UAMs: "The identification process has become increasingly difficult because foreign citizens do not usually carry any identification documents. This is especially true for juveniles who come from African countries. This is very important, given that the identification might ease the process of locating family members".
- "The identification is also made difficult since there are no prescribed procedures and protocols for assessing the age of the minor, and thus it is not rare that adult migrants declare themselves as older minors in order to avoid misdemeanor prosecution for crossing the state borders illegally, and also ensure favorable treatment which applies to minors" (SUAMME, 2015:13-15).
