# Small States International Relations and Diplomacy - Historical Background

- Historical Background -Three (four) periods of diplomatic representation
- ✓ From 1711 to early 1800s ah hoc representation and special missions
- √ From 1800s to 1878 first stable representatives without international recognition
- √ 1878 to 1918 full fledged diplomatic service
- ✓ 2006 onwards

Primary goal: independence, territorial expansions unification and(or) state preservation

- How do issues of scale, limited resources and dependence of larger/ 'kin' states affect international relations of your country?
- 1711 and Russian-Turkish war was the beginning of institutional build of the state (4 ad-hoc diplomatic missions to Moscow)
- State dependency on support and funding each mission usually resulted in some sort of material support of the Russian emperor to Montenegro (10.000 ruble in 1715)
- 1717 Venician dukal the family Radonjic

#### Small States International Relations and Diplomacy – Priorities / focus of Foreign Policy

- Which are the main general aspects / priorities / goals of your country's foreign policy and diplomacy?
- Three primary goals a) economic development, b) peace and security, c) and EU membership
- a) Dependence on FDI, bilateral agreements with countries (recently Egypt and Tailand), focused specifically on developing tourism

China – highway project ~ 900 million

Turkey – 250 to 2000 firms owned by Turkish nationals from 2017-2019

Malta among top 10

- b) NATO membership legacy of the 90s and reasurance trough global security project
- c) Primary goal insistance on the reggata principle in EU accession talks

- Mediteranian Union in Barcelona
- Western Balkans 6 Initiatiave
- Western Balkans Counter-Terrorism Initiative
- Central European Initiative 2020
- What criteria are used for choosing allies and alliances?
- Nominally alliaes are choosen on similar values and goals, rule of law, democracy, respect for human rights etc.
- De facto based on economic partneships and interests
